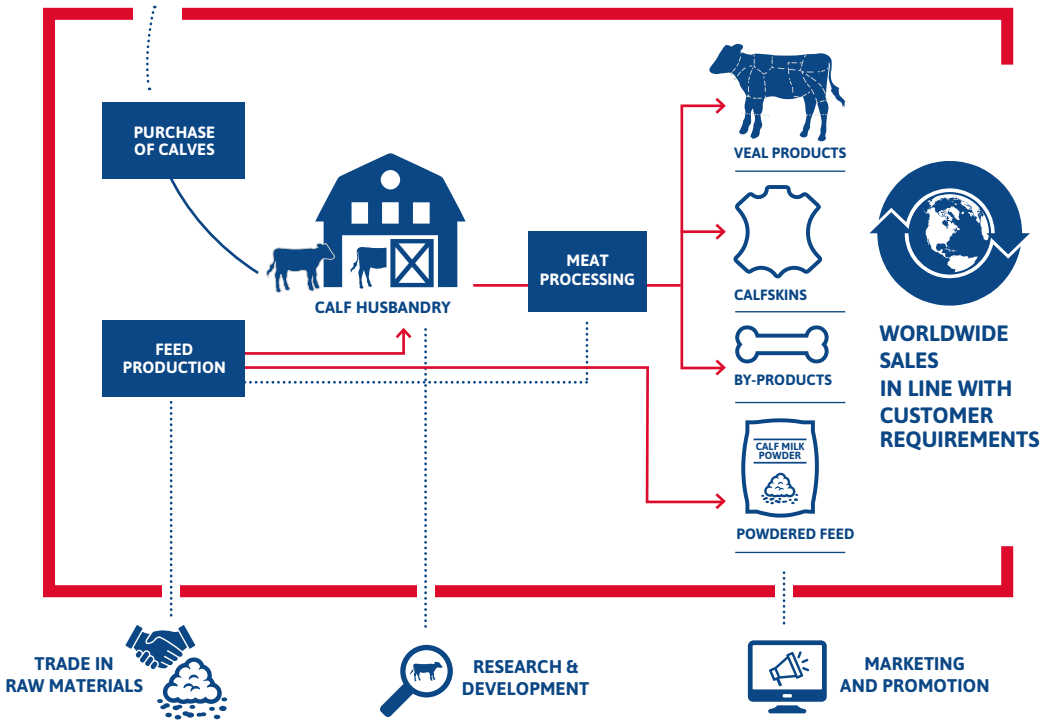

OUR ASSURANCES



VITAAL KALF ('VITAL VEAL') is the Dutch calf sector's independent quality system. It is issued by SBK, the industry association for the Dutch veal sector.



Vital Veal not only complies with European legislation, but also goes beyond it in some cases. It is aimed at helping to ensure that Dutch veal is safe, wholesome and of the highest quality. We require each farmer to be checked and certified in line with this quality system.



TRACING



Every calf is registered and the individual registration number stays with the calf for its whole life. This number also forms the basis for the unique tracking and tracing system during the meat processing activities.

FRESH WATER

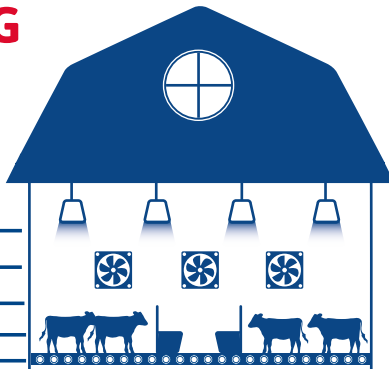


The obligatory roughage provision stimulates digestion in the rumen. This takes account of a calf's natural behaviour and enhances animal welfare.

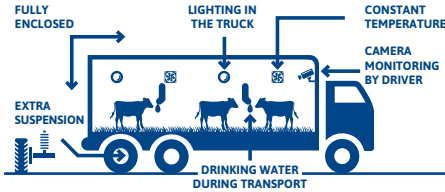
OUR PROMISE

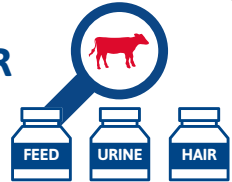
The Foundation for Quality Guarantee of the Veal Sector (SKV) is an independent organisation that carries out planned audits and unannounced inspections in all links of the production chain to ensure that no illegal substances/antibiotics are being used, either on the farm as in the feed. Every farmer is visited by SKV at least 4 times a year.
